





EXPRESSION OF INTEREST - MELBOURNE FRINGE FESTIVAL 2018

Maribyrnong City Council is calling for Expressions of Interest to perform in the Bluestone Church Arts Space as part of Fringe Westside for the Melbourne Fringe Festival 2018.

ARTS & CULTURE MARIBYRNONG

The City of Maribyrnong has a vibrant arts and creative-industries sector. It is home to a significant artist population, and contains a broad array of arts organisations and creative sector businesses. It is also home to a culturally rich and diverse community that is eager to participate in, and engage with, the arts.

At Arts & Culture, we see the arts as a source of delight, invention and provocation. They help define us as human beings and shape our view of the world. We strive to ensure that art remains a mechanism for building social cohesion and a vehicle for social justice. Participation in the arts is a source of community wellbeing and a driver of economic vitality. Put simply, our investment in the arts is a catalyst for a better community. These are the themes we wish to explore in the Bluestone Church Melbourne Fringe season.

THE BLUESTONE CHURCH ARTS SPACE

The Bluestone Church Arts Space is a flexible performance space located at 8A Hyde Street, Footscray (behind Footscray Town Hall). The former Wesleyan Church is just minutes' walk from Footscray Station, and as a dedicated arts and performance venue, is continuing the legacy of being a place where community comes together.

Offering an open plan, flat wooden floor space and exceptionally high ceilings, the Church offers a performance area of approximately 120m². For the Melbourne Fringe Festival season, the Bluestone Church Arts Space will be able to accommodate 50 people seated. Larger audiences can be accommodated but rostra would be required, which is not included as part of the Fringe Westside deal, but may be negotiated with successful applicants at an additional cost.

The venue is suitable for small-scale performances including comedy, cabaret, live music, dance, theatre or similar, and will become home to a range of quality programming during the Melbourne Fringe Festival in 2018.

THE DEAL

- Maribyrnong City Council (MCC) is providing IN KIND use of the Bluestone Church Arts
 Space for between 1-6 performance days with a maximum of 2 x performances per day.
 Double bills (two different companies sharing the space and performing on the same day) will
 be considered. Additional performances will be considered on a case by case basis.
- Artists/shows are not required to pay any hire fees, however a refundable \$200 security
 deposit is required from all applicants that accept an offer to perform in the facility. The
 security deposit will be refunded following the season, and will be retained by Council if
 damage is incurred, or if the season is cancelled by the artist/show after accepting the offer.
- Artists/shows keep 100% of box office income, less any fees that Melbourne Fringe Festival may charge.
- Ticketing is the sole responsibility of the artists/shows including complying with Melbourne Fringe Festival requirements. MCC requires 6 x complimentary tickets per season for allocation to Councillors and Senior Council Staff, and Bluestone Church Arts Space Management.
- Melbourne Fringe Festival registration procedures and fees are the sole responsibility of the artists/shows.
- The facility will be professionally managed throughout Melbourne Fringe and the Venue Manager will be provided by Council in-kind. The Venue Manager will manage the Bluestone Church Arts Space on behalf of MCC. Their main duty will be to oversee all activities and use of the facilities, which includes running the bar, ensuring the venue is clean, and all equipment is working. It is <u>not</u> the Venue Managers responsibility to operate sound or lighting for artists/shows.
- Council reserves the exclusive right to run a bar during Melbourne Fringe Festival. Artists/shows will not receive a cut or percentage of alcohol sales.
- The theatre drape system, a basic lighting rig and sound system will be provided by MCC as part of Fringe Westside this equipment is to be shared by all artists/shows throughout the Fringe season (additional equipment can be brought in or negotiated but will be solely at the artist/show's expense).
- Lighting and/or Sound Operators are to be provided by artists/shows (technical staff may be arranged through the Venue Manager for a fee).
- A Stage Manager/Front of House Manager/Ticketing Staff, and any other staff, are to be provided by the artists/shows (Some staff may be arranged through the Venue Manager for an additional fee).
- MCC will provide in kind promotion and marketing assistance as part of the Fringe Westside
 marketing and media campaigns. High res images, bios, and performance information etc
 must be supplied to MCC on request. In addition, artists/shows are expected to promote their
 own shows and manage their own specific publicity campaigns.
- All successful artists/shows must have Public Liability Insurance to the value of no less than \$10 million and will be required to complete a Bluestone Church Arts Space booking application form.
