5.5. 25 Indwe Street West Footscray

The purpose of this report was to present for consideration a planning application for the use and development of a mixed use development at 25 Indwe Street West Footscray (TP114/2017).

That Council with respect to an Application for Review against Council's failure to decide the application within the prescribed time, resolves to advise VCAT and other parties to the application, that if Council were in a position to decide on the application, the decision would have been to issue a Notice of Refusal to Grant a Permit in relation to Planning Permit Application Number TP114/2017 for the use and development of the land for industry, warehouse, child care centre, food and drink premises, office, restricted retail premises, display of signage, waiver in loading and unloading requirements for the food and drink premises, reduction in car parking and bicycle parking requirements, and construction of a fence in a Land Subject to Inundation Overlay at 25 Indwe Street, West Footscray on the following grounds:

- 1. The speculative nature of the proposal is not supported as it fails to meet the policy objectives of Clause 21.08-3 (Industrial Related Employment Land) as it does not provide any certainty on the economic and employment benefits of the proposal.
- 2. A detailed assessment of the use of the site for industry/warehouse and impacts on the surrounding area has not been undertaken due to the lack of specific information as required by Clauses 33.01 and 33.03 of the Maribyrnong Planning Scheme.
- 3. The intensity of the built form fails to protect and enhance the surrounding residential area and does not positively contribute to safety, failing to satisfy the urban design objectives of Clause 15 and Objective 5 of Clause 21.08-3 of the Maribyrnong Planning Scheme.
- 4. The proposed methods of truck access to and from the site and the associated traffic generation would unduly impact on the surrounding residential amenity, failing to satisfy Objective 4 of Clause 21.09 (Transport) and Clause 52.06 of the Maribyrnong Planning Scheme.
- 5. The reduction in car parking would unduly impact on the surrounding residential amenity, failing to satisfy Clause 52.06 of the Maribyrnong Planning Scheme.
- 6. The proposed childcare use would pose a significant risk to human health and safety in respect to the potential to land contamination and does not adequately respond to Clauses 13 and 22.03 of the Maribyrnong Planning Scheme.
