Community Recovery Committee (CRC) nominations open

A CRC was endorsed last week to support the recovery efforts post the 2022 Maribyrnong River flood event.

It will consist of a majority of community members, for a term of 18 months, who will provide guidance, support, and advice on what recovery will look like for their local community.

Expressions of interest (EOI) for nominations are open, and close at 5pm, Friday 24 February.

Through the Victorian Government's Health and Education Recovery Fund, families of school students or school students who are living independently who have been impacted by the recent floods can apply for support to replace schoolrelated items that were lost or damaged in the floods. This includes items such as uniforms, laptops, internet dongles and stationery, and is up to the value of \$1,200.

Melbourne Water are conducting a review into the October 2022 Maribyrnong River flood, and residents are invited to make a submission and contribute.


Submissions close 17 March, 2023.

Registered builders and plumbers

Flood impacted residents are being advised to ensure they check the legitimacy of builders and/or plumbers undertaking repair and rebuilding works on their homes that were damaged during the flood.

Moonee Valley Transfer Station

The timeframe for the free disposal of flood damaged personal items and waste has been extended, and the closest station is the Moonee Valley Transfer Station. To dispose of waste at the Station, you will need to show identification which includes your Maribyrnong address. You can dispose of flood damaged items until 2 March 2023.

Flood Recovery Clean Up Program

Impacted residents can still access support by calling the Flood Recovery Hotline on 1800 560 760 who can help with:

- a range of clean-up services
- finding somewhere to stay
- financial, mental health and other support.

The hotline is open from 7:30am to 7:30pm daily. Call and press 9 for an interpreter.

Building and Planning permits	Council has waived the planning permit application fees for all flood impacted residents, organisations and businesses. Any building works may also require a building permit prior to beginning, which is issued by appointment of a private building surveyor.
