# PROOF REQUIRED IF YOUR PET IS DESEXED, MICROCHIPPED OR OVER 10 YEARS OLD

If you are unable to supply proof ie. desexing certificate or veterinary report that your pet is desexed, microchipped or over 10 years old then you must complete the Statutory Declaration.

# **RESTRICTED BREED DOGS**

The Domestic Animals Act 1994 requires the following restricted breeds to be declared:

- PIT BULL TERRIER
- AMERICAN PIT BULL TERRIER
- JAPANESE TOSA
- FILA BRASILEIRO
- DOGO ARGENTINO
- PERRO DE PRESA also known as PRESA CANARIO

#### **DANGEROUS DOGS**

The Domestic Animals Act 1994 provides the following to be Dangerous Dogs:

- GUARD DOG OF NON-RESIDENTIAL PREMISES
- DOG DECLARED DANGEROUS BY ANY COUNCIL

#### **MENACING DOGS**

DOG DECLARED MENACING BY COUNCIL

#### IMPORTANT INFORMATION

The Domestic Animals Act 2012 amendments provide that any NEW registration for a microchipped domestic dog or cat no longer qualifies for a reduced fee. Please note any existing dog or cat registration at the reduced fee will still qualify for the reduced fee for the life of that animal.

#### PENSIONER DISCOUNT

Concession fees apply only to eligible recipients in accordance with the State Concessions Act 2004.

#### **PRIVACY STATEMENT**

The information provided on this form is necessary for administration and enforcement of the Domestic Animals Act 1994 and associated Maribymong Local Laws. It will be used to update the public animals register as prescribed under section 18 of the Act.

#### **STATE GOVERNMENT LEVY**

A small portion of each pet registration is paid to the Treasurer every year. The payments are primarily used to fund responsible pet ownership educational programs, administer the Domestic Animals Act 1994, support animal welfare and conduct research into domestic animal management. #### **EXCESS ANIMAL PERMIT**

Council Local Law requires a permit to keep more than 3 dogs or cats on a property. If the property is a flat a permit is required to keep more than 2 dogs or cats. Application forms are available on Council's website, www.maribyrnong.vic.gov.au

#### FOSTER CARERS VOLUNTARY ENROLMENT SCHEME

If you successfully register with Maribyrnong City Council as a foster carer you will be entitled to a reduced registration of \$8 per dog or cat fostered for the first 12 months the animal is in your care.
