### VERBAL PRESENTATION: WESTGATE TUNNEL PROJECT

#### PURPOSE

To receive a presentation on the Westgate Tunnel Project, Business Opportunities from the Business Engagement Manager, Megan Walker.

#### **ISSUES SUMMARY**

The West Gate Tunnel Project will deliver a vital alternative to the West Gate Bridge, providing a much needed second river crossing, quicker and safer journeys, and remove thousands of trucks from residential streets.

The project includes:

- West Gate Freeway precinct: upgrading and widening the freeway from 8 to 12 lanes. New express lanes between the M80 and the West Gate Bridge will reduce weaving and merging that leads to traffic congestion.
- Tunnels precinct: new tunnels from the West Gate Freeway to the Maribyrnong River, taking motorists and trucks underground and off residential streets.
- Port to City precinct: a new bridge over the Maribyrnong River and an elevated road along Footscray Road will provide direct links to the Port of Melbourne, CityLink and an extended Wurundjeri Way.

The Westgate Tunnel Project is committed to supporting local businesses. Business information sessions have been held providing information to businesses on how they can provide goods and services to the West Gate Tunnel Project and advertise directly to the 6000-strong workforce.

#### BUSINESS IMPROVEMENT DISTRICT GRANT 2017/18 PROGRAM UPDATE

#### PURPOSE

To provide an end of year summary on the achievements of the 2017/18 Business Improvement District grant program.

#### **ISSUES SUMMARY**

- The Business Improvement District (BID) grant program supports the improvement of Maribyrnong's business districts through targeted grants to trader associations and groups of five or more businesses across the city.
- The Enterprise Maribyrnong Special Committee (EMSC) has delegated authority to determine the allocation of funds.
- The 2017/18 BID program supported five projects, designed and implemented by the Footscray Asian Business Association, Footscray Traders Association, West Footscray Traders Association, African Australian Small Business Association and Yarraville Traders Association.

## BACKGROUND

The EMSC has delegated authority to provide advice on economic development issues and to determine the allocation of BID grants.

The BID grant program objectives are:

- Promote destination marketing and other opportunities to increase trade and business opportunities.
- Strengthen business districts through improved public realm initiatives.
- Increase the viability of business districts through the development of innovative business practices.
- Promote and strengthen business groups that have a shared and common economic interest.

### DISCUSSION/KEY ISSUES

#### 1. Projects

The EMSC allocated five BID grants in 2017/18 to projects:

## a) Footscray Promotional Video & Merchandise

Footscray Traders Association (FTA)

The FTA marketing project included production of a promotional short film and printing of branded shopping bags. This was delivered successfully and within budget. The film launch on 24 May 2018 was well-attended by business owners and other local stakeholders. The music used in the film was by a Footscray-based musician, Quang Dinh. The film was shared widely on social media, with more than 13,000 views as of 30 June. There are plans for a short version of the film to be screened across multiple forums including in cinema. The *Footscray* branded bags have been distributed and serve as a visual promotional tool around Footscray.

## b) West Footscray Marketing Plan

West Footscray Traders Association (WFTA)

The WFTA developed a marketing plan for the "Barkly Village" traders to inform ongoing activities to try and increase trade in the area. The project included a survey of local residents and traders and details a suite of future marketing and promotional activities for the WFTA to undertake.

## c) Footscray Saigon Night Market

Footscray Asian Business Association (FABA)

Five Saigon night markets were successfully delivered by FABA in November and December 2017 and February, March and April 2018. Each market had a different theme, with Leeds Street blocked off for food stalls and a stage featuring performances. There was significant advertising on social media, in Vietnamese newspapers and radio. FABA exceeded the original project budget contributing almost 40% of the total project funding.

## d) Afro Aussie Small Business Expo and Website

African Australian Small Business Association (AASBA)

The project plan included development of a website, training workshops and an "Afro Aussie Expo". Due to a number of delivery issues the project scope was revised. The website and two pre-expo workshops were successfully delivered.

## e) Our Village, Your Village

Yarraville Traders Association (YTA)

The original project involved several large events and activations, but was subsequently revised to focus on Mother's Day promotional campaign. The BID grant funded reusable jute shopping bags with the #yarravillevillage logo on the front. The bags were distributed by traders to encourage local trade and be a visible promotional tool around Yarraville. This was accompanied by a social media campaign with the YTA running a competition with customers encouraged to pick up a bag at a local shop and upload a photo to either Facebook or Instagram showing their bag being used. The final prize was a large hamper supplied with gifts from local businesses.

- Two drop-in sessions held at Footscray Town Hall
- Preliminary meetings with potential applicants
