PURPOSE

Richard Ponsford, Executive Officer, Western Melbourne Tourism will present on Tourism and Economic Development.

ISSUES SUMMARY

Tourism, in its many forms, is a major contributor to the economy. Visit Victoria's Annual Report states "*Travellers to and within Melbourne spent a total of \$16.2 billion (comprising of domestic daytrip, domestic overnight and international overnight expenditure)*", a 10% increase on the previous year.

Maribyrnong's Tourism and Visitation Strategy (TVS) outlines a vision for the city: *Maribyrnong is a vibrant inner-city destination and the heart of Melbourne's growing West. Visitors are attracted to the City's unique precincts that celebrate the City's cultural diversity and offers compelling and memorable experiences.*

Richard Ponsford, a passionate advocate for the west, has been working with the Western Melbourne Tourism Board since October 2012 driving the regional tourism vision of "*we aspire to help make Melbourne's West a welcoming place of urban discovery*".

PURPOSE

To provide an update on projects underway to support the endorsed 2018/2019 Business Improvement District (BID) grant projects.

ISSUES SUMMARY**Festival of Lights West Footscray**

The Festival of Lights West Footscray, a week-long Hindu cultural festival, will support the *Barkly Village Activation and Promotion* BID project promoting destination marketing and strengthening the West Footscray Traders Association.

60 traders and residents have submitted an expression of interest to have lights in their windows on Barkly Street, activating the business precinct.

The festival will be held 21 – 27 October along Barkly Street with a closing event on 28 October at Whitten Oval.

Little Africa Signs on Nicholson Street and African Women in Business Forums

Additional signage and targeted business forums will support the *Welcome to Little Africa* BID project promoting destination marketing of Footscray, improving wayfinding and strengthening the economic viability of businesses in the Little Africa precinct.

Additional signs will be installed in central Footscray incorporating part of the design suite of the *Welcome to Little Africa* project.

Forums will provide targeted training for female traders in central Footscray, who face particular challenges in navigating the complex Australian business system, language barriers and caring for extended families at the same time. The first forum will focus on visual merchandising with a second to focus on food preservation, shelf life and labelling.

Agenda Item 6.2**Saigon Plaza Big Screen**

Installation of a large screen in the recently completed Little Saigon plaza will support the *Footscray Advertising Campaign* and *Footscray Night Music* BID projects. The project will strengthen the Little Saigon precinct supporting businesses in the vicinity by encouraging increased foot traffic and visitation.

The screen would enable people to gather for live sporting events, watch movies and facilitate increased activation of the plaza.
