Purpose

The Community Recovery Committee (CRC) aims to represent the views and ideas of people in the area affected by the October Maribyrnong River flood and make recommendations to local and state governments to assist community recovery.

Scope

The CRC will:

- Identify and present issues arising from the impact of the flood on individuals, families and communities and prioritise them for action.
- Advise a range of government and non-government organisations on appropriate actions for recovery.
- Undertake appropriate actions for recovery and proactive community building in partnership with a range of government and non-government organisations.
- Create a feedback loop using reference group members, social, informal and formal networks to connect community, government and non-government agencies.
