

Introduction

Purpose

We recognise the value of pet ownership, its overall benefit for our health and wellbeing, the importance of welfare for pets and the protection of the community and the local environment from nuisance dogs and cats.

The Domestic Animal Management Plan (DAMP) aims to help us balance the needs of pet owners with the needs of the rest of our community.

The DAMP also outlines Council's approach to the delivery of animal management services, programs and strategies across the City of Maribyrnong over the next four years.

Statutory Requirements

Under Section 68A of the *Domestic Animals Act 1994* (Act), every Victorian Council must prepare a DAMP every four years. The DAMP must:

- Set out a method for evaluating whether animal control services provided by Council are adequate to give effect to the requirements of the Act and regulations.
- Outline programs for the training of authorised officers.
- Outline programs, services and strategies to:
 - Promote and encourage responsible ownership of dogs and cats;
 - Ensure that people comply with the Act, regulations and legislation;
 - Minimise risk of attacks by dogs on people and animals;
 - Address over-population and high euthanasia rates for dogs and cats;
 - Encourage registration and identification of dogs and cats;
 - Minimise potential for dogs and cats to create a nuisance;
 - Effectively identify all dangerous, menacing and restricted breed dogs and ensure that these dogs are kept in compliance with Act and regulations;
 - Provide for review of existing orders made under the Act and Council's Local Laws;
 - Provide for review of any other matters related to management of dogs and cats; and,
 - Provide for periodic monitoring and evaluation of the Plan.

Every Council must review its Plan annually and publish an evaluation of its implementation in its Annual Report.



Strategic Alignment

The DAMP supports the Council Plan 2025-2029 vision of a sustainable, vibrant city where history is acknowledged, differences are respected, and diverse communities are supported to connect and thrive.

Process

The DAMP was developed in consultation with Council's Animal Management Team, and informed by community and stakeholder consultation, research and benchmarking activities.

It seeks to balance community and stakeholder needs, whilst ensuring compliance with the requirements of the Act.



City of Maribyrnong Profile

People

The City of Maribyrnong is located in Melbourne's inner west and is made up of nine suburbs – Braybrook, Footscray, Kingsville, Maidstone, Maribyrnong, Seddon, Tottenham, West Footscray and Yarraville – with a total land area of 31 square kilometres. The suburbs vary in demographics and social and economic status.

Maribyrnong is a thriving hub of arts, culture, retail, education and innovation. People are attracted by the period homes, 'foodie' culture, the natural environment of the Maribyrnong River and open spaces, access to public transport, job opportunities and the close proximity to Melbourne's city centre and airports.

Maribyrnong has 153 open spaces, covering 313.5 hectares of land or 10 percent of the total land area of the municipality which is much lower than the surrounding municipalities. Open spaces are highly valued and highly utilised by pet owners and non-pet owners alike. 53% of the estimated 94,251 residents (ABS ERP 2024) live in medium to high density housing.

Maribyrnong is culturally and linguistically diverse with 38% of residents born overseas. The main countries of birth, apart from Australia include Vietnam, India, China, the United Kingdom and New Zealand. The ethnic composition is comparable to Greater Melbourne, where 36% of people identified as having been born overseas.

The median age of residents is 35 years, with a smaller percentage of 'seniors', 'empty nesters and retirees'; and a larger percentage of 'young workforce' and 'parents and homebuilders' than Greater Melbourne.

The Future

Maribyrnong's population is forecast to grow by more than 60,000 residents by 2051. Increased resident population has a flow on effect on the number of pets in Maribyrnong. This impacts the number of animal registrations, dogs being walked in public open spaces, cats needing to be contained to properties, dogs potentially barking, and much more.

Our parks need to be welcoming to all members of the community, including pet owners, and cater for various and increased use as they become residents' 'backyards'.

This includes responding to an increased number of domestic animals residing in the municipality and living in apartments, as well as providing a balanced approach to ensuring that our limited open spaces are well managed and shared between dog owners and non-dog owners.

Protection of our environment and wildlife from dogs and cats at large will continue to be a priority. We will implement initiatives to increase community awareness and reduce impacts of dogs and cats on the environment.



Local Laws, Orders and other Domestic Animal Controls

In addition to The Act, Council enforces the provisions of the Local Law and Council Orders which relate to animal management as outlined below.

Keeping dogs and cats

Dogs and cats over three months old must be microchipped and registered with Council.

The maximum number of dogs that can be kept is as follows:

Animal	Houses	Units, townhouses, apartments, flats and other multi-residential dwellings
Dogs	3	2
Cats	2	2

Exemptions are provided for cats and dogs under 12 weeks of age.

An assistance dog or cat may be kept, provided it is registered with Council.

Animal housing and noise

Owners are required to ensure that animal housing is appropriate for the number and type of animals, minimises noise and other nuisances, and does not adversely impact the amenity of the area.

Animal waste

Pet owners are required to pick up after their pets (and carry waste bags).

Dogs on/off leash

Dogs must always be on leash in public places, except in specifically designated off leash areas.

When dogs are off-leash it is the responsibility of the owner/handler to:

- Observe park signage always in all parks, gardens, reserves and other public open spaces.
- Clean up after dogs.
- Carry a chain, cord or leash and be able to bring their dog under effective control if the dog behaves in a manner which causes any person or animal to feel threatened or worried.
- Remain in effective voice or hand control of their dog so that the dog can be brought under effective control should it become necessary.
- Ensure that dogs do not cause worry or threaten any person or animal.



When dogs are on-lead it is the responsibility of the owner/handler to:

- Clean up after their dog.
- Ensure that the dog is under effective control of the owner/handler by means of a chain, cord, or leash no longer than three metres which is held by the owner/handler and attached to the dog.

Dogs on sporting grounds

Under no circumstances are dogs permitted to enter onto sports grounds when booked sports training or matches are taking place.

Dogs in playgrounds

Under no circumstances are dogs permitted to enter playground areas without being on a lead. Dogs that are off-lead are not permitted to be within 30 metres of any playground area.

Training of Authorised Officers

Council's Animal Management Team are part of the Emergency Management and Regulatory Services Department. Council employs 4.0 FTE Authorised Officers, who during 2024-25 responded to 1,447 domestic animal management requests.

Animal Management services are provided 8.30am to 5pm, Monday to Friday.

After hours reports/calls are actioned by The Lost Dogs Home.

Current activities

Given the diverse roles and activities undertaken, it is critical that all staff involved in animal management have the knowledge and skills necessary to carry out their work.

Authorised Officers are encouraged to hold a Certificate IV in Animal Control and Regulation or equally appropriate and applicable qualifications and experience.

New staff are required to complete specific training including a Council induction on policies and standard operating safety procedures and introduction to Council's Animal Management procedures and programs. Regular team training and refresher courses and ongoing on the job training and coaching is provided.

We maintain a training needs analysis detailing all the qualifications and training courses completed by each officer. We undertake annual performance reviews to identify further training and development opportunities with targeted training provided.

Promote and encourage responsible pet ownership

Education and promotion initiatives are essential to encourage the responsible ownership of dogs and cats. Responsible pet ownership includes animals being trained and exercised, microchipped, desexed and registered with owners who comply with regulations and signage.

We promote and encourage the responsible ownership of dogs and cats through a range of education and enforcement initiatives. We understand the increasing demand for Council services to be delivered online, and for engagement through social media and other digital means.

The promotion of dog friendly and dog prohibited spaces is important in increasing community awareness of where and when you are able to walk your dog.

The implementation of a dusk-to-dawn (7pm-7am) curfew with consideration of a phased approach to a full 24/7 curfew, Cat Confinement Order and mandatory cat desexing across Maribyrnong will require targeted community education initiatives to ensure awareness of cat confinement requirements.

Reducing overpopulation and euthanasia

Impoundments occur when pets escape from their properties or are abandoned or surrendered by owners. Council's priority is to achieve positive community and animal welfare outcomes and return registered pets to owners from the field wherever possible, without taking them to the Lost Dogs' Home.

Council has a contract with the Lost Dogs' Home to collect uncontained dogs and cats and assist them in being returned to their owner or where this is not possible - to be rehomed.

The Lost Dogs' Home's goal is to reunite healthy and treatable animals with their owners or adopt them into new homes. They rehome and reunite the majority of dogs and cats that come into their care. Animals are only euthanised as a last resort. "If the health condition is chronic and pain cannot be alleviated or quality of life is acutely impeded, it is considered humane to relieve an animals' suffering with compassionate euthanasia."

It is Council's aim to reduce the euthanasia rates and overpopulation levels by working with the community to increase the number of desexed, microchipped and registered animals in the municipality.

Council does not register pets that are not microchipped and ensures animals are registered prior to releasing them once impounded. When Council becomes aware of an unregistered cat or dog, follow up is conducted and assistance provided to ensure the pet gets registered.



Community engagement outcomes from a 2024 survey of 995 people identified that:

- 76% of respondents support the introduction of a cat curfew.
- 66% of those who support the introduction of a cat curfew reported that they support a 24/7 cat curfew.
- The primary reason for supporting a cat curfew was impact on local wildlife.

Current activities

- Council contracts its animal collection and pound services to The Lost Dogs' Home which is open to the public every day (except Christmas Day and Good Friday).
- Online 'lost dog' and 'lost cat' search facility through the Lost Dogs Home.
- Promotion of pets available for adoption through the Lost Dogs Home.
- Liaise with and report animal welfare/cruelty matters to the RSPCA for action.
- Enforce Local Law provisions governing the number of animals that can be kept on a property without a permit.
- Enforce Local Law provisions governing the responsible breeding of dogs and cats.
- Conduct investigations in response to customer requests.
- Enforcement activities including official warnings, infringements, notices to comply and court prosecution.




Registration and identification

The registration and identification of dogs and cats is important in demonstrating responsible pet ownership and in caring for the welfare of animals. As well as being a legal requirement, an animal found with current registration and microchip has a much higher chance of being reunited with its owner.

All dogs and cats three months and over must be microchipped and registered with Council. Cats are also required to be desexed. Registrations must be renewed annually by 10 April.


There have been fluctuating animal registration numbers, reflecting a need to increase awareness of the importance of pet registration. There are plans in this DAMP to highlight the benefits of pet registration in order to increase registration numbers with one of the key benefits of enabling lost pets to be returned to their owner.





Current activities

- Annual registration renewal notices and follow up process, including SMS reminders. Educational material is also sent with renewal notices.
- Online portal for new registration applications and payment of renewals.
- Free registration for guide dogs, seeing eye dogs and assistance dogs.
- Lifetime registration tags.
- Educational media campaigns and online promotions.
- Cross-referencing of Central Animal Records (CAR) microchip database with Council's animal registration database.
- Registration door knock activities.
- Animals in the Lost Dogs' Home must be registered and microchipped prior to release.
- Proactive patrols in the community, where registration is checked and followed up for all interactions officers have with members of the public.
- Enforcement activities including notices to comply, official warnings, infringements and court prosecution.





Nuisance

We hope to encourage people to manage their pets in a way that protects the health and welfare of the animal, maximises the companion benefits of their pet, and minimises potential for nuisance or harm to others.

In 2024-25, Authorised Officers responded to 1,447 domestic animal requests. The most frequent animal management requests are detailed below.



Dogs off lead and stray dogs make up 22% of requests. Although regular and proactive patrols are undertaken, community education and voluntary compliance are critical as only a small portion of public open space areas can be patrolled at a time.

Nuisance or stray cats remain a concern making up 25% of activity, although cats are currently not required to be confined to their owners' premises. Unowned and feral cats will continue to be both a nuisance for the community and a negative environmental impact without adequate management into the future. Council is looking to focus on responsible cat ownership in this DAMP.

There is an opportunity to increase community awareness around responsible pet ownership of both dogs and cats.



Current Activities

- Proactive patrols of dog off-leash parks and reserves.
- Signage in dog off-leash parks detailing dog controls.
- Information provided to reduce nuisance and promote the 12 designated dog off-leash areas, including:
 - Barking dog booklet.
 - Dog off leash area.
 - Picking up after your dog.
 - Reporting a nuisance dog or cat.
- Signage and waste bags in the 12 designated dog off-leash areas.
- Enforce Local Law provisions governing the number of animals that can be kept on a property without a permit.
- Enforce Council orders and regulations such as those governing dogs on sports grounds or near playgrounds.
- Conduct investigations in response to customer requests regarding nuisance associated with dogs and cats.
- Enforcement activities including notices to comply, official warnings, infringements and court prosecution.

Dog attacks

Dog attacks remain a concern and Council continuously looks for ways to minimise dog attacks on people and animals. We do this by means of a range of proactive communication initiatives and investigation and enforcement action against offending dog owners.

A dog attack is a bite or injury to a person, whereas a rush is where a dog has approached a person within three metres displaying aggressive behaviour (e.g. snarling, growling, barking, raising hackles).

In 2024-2025 Authorised Officers responded to 97 reports of alleged dog attacks or rushes and Council successfully prosecuted seven serious dog attacks.

Education, access to dog training and enforcement of local laws / greater physical presence in the community are important in minimising dog aggression and attacks in the community.


Current activities

- An immediate response to reports of dog attacks.
- Where the threat is not imminent, a response within one hour to reports of dangerous dogs.
- Conduct investigations in response to customer requests regarding dog attack, rush or aggression.
- Signage in dog off-leash parks and reserves detailing dog controls.
- Proactive patrols of dog off-leash parks and reserves.
- Information provided to reduce instances of dog aggression and promote designated dog off leash parks.
- Enforcement activities including notices to comply, official warnings, infringements and court prosecution.

Dangerous, menacing and restricted breed dogs

Council seeks to minimise the risk to the community by administering and enforcing the provisions of the Act to identify and control dangerous, menacing and restricted breed dogs.

In 2025, Maribyrnong City Council has 17 declared dogs:

- 4 declared as dangerous dogs;
- 13 declared as menacing dogs; and
- 0 restricted breed dogs.

Our pet registration forms require owners to declare if their dog is a restricted breed, has been declared menacing or is a dangerous dog.

Current activities

- Record all declared dogs on the Victorian Declared Dog Registry and conduct annual audits of properties and leasing and housing requirements.
- Conduct investigations in response to reports of declared dogs.
- Conduct Central Animal Records microchip audits to identify potential restricted breed dogs.
- Information on website and available at Council offices.
- Enforcement activities including notices to comply, official warnings, infringements and court prosecution.

Actions for 2026-29

Domestic Animal Businesses

Council works in partnership with Domestic Animal Businesses to make sure businesses are registered and complying with relevant regulations.

Maribyrnong has 11 registered Domestic Animal Businesses:

- 1 breeding and rearing establishment;
- 6 boarding establishments;
- 2 dog training establishments; and
- 2 pet shops.


Authorised Officers inspect these facilities annually to ensure compliance with the relevant Code of Practice under the Act, prior to registration renewal.

Council has the ability to issue notices to comply, warnings, infringements, or to prosecute businesses that fail to comply with work plans and the relevant Code of Practice.

We actively seek to identify, investigate and prosecute any illegal Domestic Animal Businesses operating in Maribyrnong City Council.

Current activities



Review and Evaluation

Section 68A(3) of The Act requires that every Council must:

- a) review its Domestic Animal Management Plan annually and, if appropriate, amend the Plan;
- b) provide the Secretary with a copy of the Plan and any amendments to the plan; and
- c) publish an evaluation of its implementation of the Plan in its annual report.

Performance monitoring and evaluation process

Council will monitor performance of the objectives that are detailed throughout the DAMP by reporting annually through Council's established reporting systems, in accordance with the requirements of The Act and the Local Government Performance Reporting Framework.

A new DAMP will be completed on or before 30 November 2029.
