#### **PURPOSE**

To receive a presentation on the proposed Kaufland Store for Braybrook from James Somlai and Colin Rimmer of Kaufland Pty Ltd.

#### **ISSUES SUMMARY**

- Kaufland Pty Ltd is a European grocery chain and subsidiary of the world's fourth largest retailer. The company has proposed opening a supermarket in the City of Maribyrnong at 81-85 Ashley Street, Braybrook.
- An Advisory Committee has been appointed to provide advice to the Victorian Minister for Planning. They considered six original sites in Dandenong, Epping, Chirnside Park, Coolaroo, Oakleigh South and Mornington.
- A further nine sites were referred to the Advisory Committee in August 2019, namely Pakenham, Lyndhurst, Narre Warren, Bendigo, Geelong, Coburg, Warrnambool, South Morang and Braybrook.
- Public consultation will be undertaken by DELWP, with approximately 400 owners, occupiers and businesses to be notified.

#### **ISSUES SUMMARY**

- Six projects were awarded funding by Enterprise Maribyrnong Special Committee at the meeting on 6 August 2019:
  - Sustainable Footscray Footscray Traders Association
  - Visit Seddon Seddon Village Traders Association
  - Destination Yarraville Yarraville Traders Association
  - Seddon Weddings Collective Group of five businesses led by Cakes & Vases
  - Buckley's Group of five businesses led by Lay Low Bar.
- Four of the BID grant recipients have commenced their projects. The two remaining recipients are in the process of meeting Council's governance conditions prior to signing their funding agreements.
- The first major BID grant event is the Festival of Lights which will take place at Whitten Oval in West Footscray on Saturday 12 October 2019.
- Council have met with the Footscray Asian Business Association and are in the process of co-organising a supporting project with the remaining funds in the BID grant pool.
