

2024/25 NYE Fireworks Food Truck Terms & Conditions

Tuesday 31 Dec 2024, 6.00 – 10.30pm

Footscray Park Western Lawn

Applications: Council only accepts applications for food trucks for this event. Temporary food stalls (ie. marquee/tent style) will not be considered.

Selection Process: All applications will be processed by the Event Manager to ensure appropriateness to the event, and so that a balanced selection of food and beverage offerings are available. The final decision rests with Council.

Fees and Charges for MCC registered food vendors:

- A site fee is applicable of \$545 (including gst).

Please note: Food Trucks that are registered with Maribyrnong City Council do not have exclusivity over non-MCC registered food vendors to trade at Council's NYE Fireworks event. Invitations to successful applicants will be sent following the EOI process.

Fees and Charges for non-MCC-registered food vendors:

- A site fee is applicable of \$700 (including gst)

Site fees are due by 4pm Friday 8 December 2023. Please note, this is a no refund event.

Insurance: All operators must have Public Liability Insurance with a minimum of \$20 million. Council requires a copy of the operator's PLI certificate of currency with the application.

Single-Use Plastics: All food operators are to be environmentally aware when planning their food and beverage offerings for this event. MCC has adopted a ban on Single-Use Plastics for this event. Plastic bags, straws, balloons, plastic bottled drinks, disposable plastic crockery, and cups are not allowed on site. All food vendors must replace these disposable items with reusable and recycled items such as bioplastics, plant-based, and paper products.

Health Requirements: All food operators must comply with safe food handling practices in accordance with Maribyrnong City Council's Health Department requirements. All vendors that sell any type of consumable product (food, beverages) must be registered with Streatrader and submit a Statement of Trade (SOT) to operate at this event.

Fire safety: All food vendors must have a fire extinguisher or fire blanket within the food truck when entering the site to trade.

Generators and Leads: Council will provide access to generator power for food trucks. Food operators need to provide all leads which must be tested and tagged. The generator may be up to ten metres from your truck.

Applications and Site Specifications: Food truck sizes must be outlined in the application form. Vendors are required to contain their activities in the immediate area of their food truck. Where activities need to extend beyond these boundaries, permission must be sought and approved in writing from the Event Manager by the date specified on the application form. There is NO roving promotional distribution allowed at the event.

Bump in and Out: Set up is on the day of the event, Tuesday 31 December 2024 from 12pm to 4pm. Food trucks that arrive after this time will be refused entry.

All support vehicles must leave Footscray Park by 4.00pm. Traffic Officers will be patrolling for the duration of the event and will issue on the spot fines for cars that remain on site.

There is NO early bump out/ pack-up at this event. Vehicle egress will not be made available until 11.30pm or until the Safety Officer has deemed the site safe for vehicle exit.

Operating times: Vendors are able to operate from 5.00 – 10.30pm.

Council will not accept applications from and reserves the right to enforce a cessation of activities, of vendors, groups, or individuals who provide activities or materials which are perceived as offensive or defamatory or in direct conflict with Council endorsed policy positions. All branded goods must be accompanied by appropriate documentation. No counterfeit goods will be accepted.
