	<p><b>Welcome and Acknowledgement of Country</b></p> <p>The Chair began the meeting by acknowledging the Traditional Owners of the land, the Wurundjeri Woi Wurrung and Bunurong people of the Kulin Nation.</p>
1	<p>The Chair introduced Jason Collins, who has recently joined Council as Coordinator Emergency Management. Jason's experience includes Director Community Preparedness at the New South Wales Reconstruction Authority, Chief Officer Northern Territory Emergency Services, as well as positions in local government and the Australian Red Cross. Members welcomed Jason.</p>
2	<p><b>Conflict of interest declaration</b></p> <p>No conflicts were declared.</p>
	<p><b>Endorsement of previous minutes</b></p>
3	<p>Members endorsed the previous minutes. They requested the Melbourne Water fact sheet be included as an attachment and shared amongst community as it contains additional information from the Melbourne Water presentation.</p>
	<p><b>Energy check-in</b></p> <p>The Chair asked members about their energy levels. Members noted:</p> <ul style="list-style-type: none"> <li>• Every day feels different, and it has been a long journey for CRC members.</li> <li>• Some members still have concerns about the future and safety.</li> <li>• People are at varying stages of recovery.</li> <li>• The third anniversary event was positive and well received. CRC members felt proud that the community appreciated the work invested in the program.</li> </ul>
	<p><b>Program overview and gaps</b></p> <p>The Chair provided an overview of the program delivered by the CRC and asked whether there are still gaps to address. Members noted:</p>
4	<ul style="list-style-type: none"> <li>• It was beneficial to have Melbourne Water and VicSES representatives attend the last meeting, but more engagement and information sharing are needed.</li> <li>• The Maribyrnong Neighbourhood Flood Network will take on an information-sharing role.</li> <li>• There remains a need to rebuild trust.</li> <li>• Advocating for an independent review of agencies' responses after the flood would help measure improvements.</li> <li>• A proactive list of supports and a guide to navigating next steps after a flood should be developed and launched through the Neighbourhood Flood Network to assist community members in the future.</li> <li>• Council should showcase operational changes made post-flood based on lessons learned.</li> <li>• Cr Yengi noted that developing a guide outlining the responsibilities of each agency involved in emergency management would be helpful. This was one of the recommendations from the Maribyrnong Community Planning Day workshop in May 2025.</li> </ul>

## Flood Recovery and Prevention Advocacy

Discussion led by Elle Schreiber, Coordinator CEO Office:

- Elle advised members that the Advocacy Plan 2025–28 has been endorsed. An update on progress will be presented to Councillors in six months.
- The plan incorporates advocacy asks from the Strategic Advocacy Plan Flood Recovery, identified through the CRC and the needs assessment from the Maribyrnong Insurance Project.
- The CEO's Office is seeking community feedback on the plan, noting that the asks can be amended where required.

Members suggested the following:

- Build partnerships with other communities, both within Victoria and interstate, to progress advocacy asks — including convening an Insurance Round Table.
- Review findings from the Parliament of Victoria's Inquiry into the 2022 Flood Event in Victoria.
- Help the community understand what the Plan means for them.
- Develop a strong case with both economic and human justification for why change is necessary.
- Invite Federal and State Members of Parliament, Daniel Mulino MP and Katie Hall MP to an upcoming meeting.
- Create a concrete action plan for advocacy asks.

Insurance Round Table discussion:

- Members noted there are significant challenges with insurance – an Insurance Round Table was suggested with key stakeholders to hear about community challenges and discuss opportunities for action.
- Members advised that many residents accepted early cash settlements but later regretted it, as the amounts were insufficient to cover actual costs.
- Inconsistencies across policies were highlighted, particularly regarding accommodation allowances. Members stressed the need to advocate for more than one year of accommodation to be included in all policies.
- Case studies and personal quotes were identified as critical tools to apply pressure on stakeholders and the federal government for action.

**Actions – Council to:**

- Draft an advocacy brochure to be shared with key stakeholders
- Confirm if the Inquiry into Insurers Response to 2022 Major Flood Claims contained recommendations on accommodation
- Scope feasibility for an Insurance Round Table
