Meeting the housing needs of local communities

Homes Victoria is delivering more and better social and affordable housing across Victoria.

We are committed to meeting the diverse needs of each community across Victoria. In developing proposals for new housing, we look closely at demand in local areas, and design homes that are accessible.



Proposal for new homes

We have recently submitted proposed plans to Maribyrnong City Council to redevelop 8-10 Middleton Street, Braybrook, to provide 16 modern, energy efficient and accessible homes.

Previous use of this site

Previously, there were two older houses on this site. These houses had reached the end of their useful life.

In the interests of making the site safe, we undertook the demolition of these houses in October 2024.

Viewing plans and providing feedback

Homes Victoria is committed to providing the community with information on the planning we're undertaking.

Members of the community are invited to view the plans and provide feedback, which will be considered as part of the application process.

As part of the planning application process, the proposed building and landscaping designs are available through Maribyrnong City Council.





What is the Future Homes program?

The Future Homes program is a Department of Transport and Planning (DTP) initiative that provides four exemplar designs for high-quality, sustainable and liveable three-storey housing developments.

Developments that use these exemplar designs have received endorsement from industry and design panels, and as a result, they are able to access streamlined planning processes.

Homes Victoria has used a Future Homes design for the proposed plan for 8-10 Middleton Street.

We have presented our plans to DTP and the Office of the Victorian Government Architect (OVGA), and incorporated their feedback, prior to submitting a planning application to council.

Can community give feedback on plans that use Future Homes designs?

Yes. Neighbours will receive notification from council about consultation periods and signage will be in place on the proposed site.

Community feedback will be carefully considered as part of the assessment of the project.

Why is the building 3-storeys high?

To meet the significant demand for more and better homes in this area, Homes Victoria is proposing a building that is well designed, energy efficient, with good levels of accessibility and well located near transport and shops.

To ensure the homes cater to a wide range of people and to ensure they can stay in these homes for a long time, the building includes an elevator. This ensures the homes can be used by older residents who may use mobility devices, or those with prams.

Including an elevator in the building is only feasible with three storeys and is a key reason for the three-storey design.

Why has this location been chosen?

This location has been chosen because it is close to public transport, schools, shops and services - making it ideal for new homes.



Will these homes be social housing?

The new homes will be social housing. This means they will be allocated to households from the Victorian Housing Register.

How will future residents be supported?

When new residents move in, we will help residents access the supports available to them – such as health, employment and social supports.

Why does it look like works are happening on site already?

This project is at the planning and development stage – this needs to occur before construction can happen.

You may see some activity on site in coming weeks and months. This is not construction work.

As part of our planning work, we engage a range of specialists to review and assess the site. This can include arborists undertaking assessment of trees and vegetation, location of services such as water, gas and electricity and other specialists taking soil samples, to understand ground conditions.
