The Responsible Authority must make a copy of every objection available for any person to inspect free of charge until the end of the period during which an application may be made for review of a decision on the application.

Please note that the proposed development only requires a planning permit subject to the provisions of the Heritage Overlay. As such, Council's consideration of the application is limited to the decision guidelines of Clause 43.01 - Heritage Overlay, of the Maribyrnong Planning Scheme. Consequently, a ResCode (Clause 54) assessment will not be undertaken as part of this consideration and the effect on the amenity of adjoining properties cannot be considered. The site is listed on the Victoria Heritage Register. For this reason, all works to the original building require separate approval from Heritage Victoria and is not considered as part of this application.
