#### 4. PUBLIC QUESTION TIME

Public Question Time commenced at 6:33pm and 1 question was received.

### Jesse McNelis asked the following question:

1. The 'YourCity YourVoice' website is currently running a survey to inform the Annual Budget 2024/25.

People are asked to select their top five priorities of the services Council delivers to shape how and where money should be spent next year. From the previous survey for the 2023/2024 budget, the top five priorities chosen were:

- Open space
- Sustainability and the environment
- Cycling and pedestrian infrastructure
- City amenity and safety
- Community centres and libraries

Could the Council tell me how much (\$dollar amount) and what percentage of the total budget was allocated to each of these individual priorities in the 2023/2024 budget?

Response: Council is currently seeking feedback from the community via the Your City Your Voice to help inform the development of the Proposed Budget 2024/25 which will be shared back with the community for further feedback in April.

> Two primary tools are being used on the on-line portal - the 'fund-it' tool and a formal feedback form.

> The fund-it tool is not a survey. It is an opportunity for the community to identify five services areas that are most important to them.

> Along with putting forward a budget/proposal idea, the formal feedback form allows community members to provide detailed feedback and information to explain their reasons for their choice of service areas.

> Both the 'fund-it tool' and feedback form enable us to gather information and thinking from our community that helps inform the development of the Proposed Budget 2024/25, alongside other factors and considerations, such as asset condition and previous funding commitments and decisions made by Council.

> During engagement on the 2023/24 Budget, the top five service areas identified by residents who provided input via the 'fund-it' tool were:

- Open space
- Sustainability and the environment
- Cycling and pedestrian infrastructure
- City amenity and safety
- Community centres and libraries

Just under 30% of funding in the 2023/24 Budget was allocated to the these service areas

Including both capital and operating budgets, this was broken down into:

- City amenity and safety \$8,627,000 or 4%
- Community centres and libraries \$9,006,000 or 4%
- Cycling and pedestrian infrastructure \$5,150,000 or 2%
- Open space \$25,163,000 or 11%
- Sustainability and the environment \$17,356,000 or 8 %

### **Committee Resolution**

That the City Development Delegated Committee issues a Notice of Refusal to Grant a Planning Permit based on the following grounds:

- 1. The proposal is contrary to the purpose of the Industrial 3 Zone (Clause 33.03) as it does not provide a use which is compatible with the nearby community and would unreasonably affect the safety and amenity of adjacent, more sensitive land uses.
- 2. The proposal fails to satisfy the relevant decision guidelines of the Industrial 3 Zone (Clause 33.03-2) for the following reasons:
  - a. The proposal encroaches into an area intended as a buffer between industrial uses and local communities.
  - b. The proposal would result in adverse amenity impacts on nearby properties in terms of noise, odour and emissions.
  - c. The proposal would result in excessive traffic and associated amenity impacts on nearby roads.
- 3. The proposal has failed to adequately demonstrate how it would have no unreasonable impacts on the air quality of the surrounding area.
