5. Submissions must include a detailed drainage plan, computations and a compliance certificate.
6. All submissions are to be emailed to DrainagePlans@maribyrnong.vic.gov.au.
7. It is **applicant's responsibility** to undertake due-diligence for underground assets, by phoning Dial Before You Dig on **1100** for existing underground service information.
8. Applicants must apply for a drainage inspection prior to booking an on-site inspection (Form 3, fees apply).
9. A Working Within the Road Reserve Permit must be obtained prior to applying for an inspection (fees apply).
